PLEASE READ BEFORE COMPLETING THE APPLICATION FORMS

For admission to our Transitional Kindergarten (TK), your child must turn 4 by October 15, 2023.

For admission to Kindergarten, your child must turn 5 by October 15, 2023.

The application deadline for both TK and Kindergarten is February 15, 2023, with all admissions decisions made by March 1, 2023. Applications for transfer students in 1st through 8th grades are done on a rolling basis, dependent upon available space in a given grade level.

The following documents must be submitted when your child has applied or has been accepted into the school.

1. **Application Fee:** A non-refundable application fee of \$35.00 per applicant. This fee covers the processing of applications.
2. **Birth Certificate:** Please provide a copy of the birth certificate.
3. **Baptismal/First Communion Certificates:** Please provide a copy of these certificates, if Catholic.
4. **Verification of Immunizations:** **A child may not attend school without the following on file:** Medical records which prove that your child has had the required immunizations for school entry. Incoming TK, Kindergarten, and newly-enrolling 1st Grade students are also required to have a health check-up before school entry. The check-up must be sometime within 18 months before entry into 1st grade or 90 days after entry into 1st grade. This is mandated by the State of California Child Health and Disability Prevention Program. Parents must submit a “Report of Health Examination for School Entry” (PM 171A) to the front office by August 25, 2023.
5. Transfer students in Grades 1st through 8th must include a copy of **current report card and test scores.**

PARENT'S GUIDE TO IMMUNIZATION REQUIREMENTS

This is what is needed at the time application is made to the school.

You will need to provide a copy of your child's *verified immunization record* with the application. It must show the date (month/day/year) your child was given each required shot.

If your child's record is missing some doses, please contact your doctor or clinic soon to schedule an appointment for when these doses will be due. **Important: State Law requires the school to refuse attendance to children until all requirements have been met.**

Your child may be exempted for a medical condition by submitting a written statement from a licensed physician.

CHECK UP REQUIREMENT FOR INCOMING KINDERGARTENERS AND 1ST GRADERS

Another requirement is that your child has a *health checkup* before school entry. The checkup must be sometime within 18 months before entry into 1st grade or 90 days after entry into 1st grade. Parents must submit "Report of Health Examination for School Entry" (PM 171A). The school requires that this form be completed by your child's physician or health clinic and be on file in our school office by August 25, 2023.

This is mandatory for all incoming TK, Kindergarten, and newly-enrolling 1st grade students.

REQUIREMENT FOR INCOMING 7TH GRADE STUDENTS

All students going into 7th grade must have proof of having had the Tdap booster shot before starting school.
